1) **Enrollment fee** – the full amount **MUST** be paid immediately by bank transfer or credit card, please reply to us a proof of the happened payment. Any bank commission is on student charge.

3) The student agrees to pay the full enrollment amount in order to guarantee the study place in the course.

4) The student can exert his right of withdrawal on condition that he expresses that will within ten days from the signature of this contract through registered letter with return receipt sent to Florence Design Academy.
